Step 5: On successful submission of the Application Form & deposit of application fee, you will be able to view the complete application submitted by you, including your Photo along with the message of Successful submission by clicking on track your application form. Please take a printout of this application form for future correspondence & **Application Sequence Number** printed on it.

Step 6: Deposit the requisite Application fees through online/offline mode via **State Bank of India** payment gateway. Make sure that candidate is able to make payment after one working day. After getting confirmation for successful submission of application, candidate may be precisely advised to make payment between next day dates to last date



GENERAL CONDITIONS

1. Aspiring applicants satisfying eligibility criteria in all respect can submit their ONLINE application only. On-line application (s) will be available on SGPGIMS, Lucknow websites www.sgpgms.org.in. Candidates should read the said advertisement carefully and understand very well that they have the desired qualifications for the advertised posts and are covered under the prescribed age limit (Minimum-18 years Maximum- 50 Years / 55 years in case of Deputation(Ref.- UP Absorption of Government Servants in Public Undertakings Rule, 1984)
2. Applicants must fulfill all essential eligibility criteria, educational qualification, age limit, etc. as per above detail.
3. Amount of non-refundable fee to be paid in respect of one post is as under:-

The candidates belonging to the other category (Horizontal) shall have to pay fee according to their original category.



4. Individual application and application fee is required to be submitted/ remitted for each post(s) separately. (In case of candidate applying for more than one post).
5. On-line Registration and submission process schedule will be published on Institute's website; Interviews will be conducted according to the schedule which will be communicated in due course of time through e-mail /SMS/Website.
6. Before applying, candidates must read the mandatory qualifications (academic) and other prescribed experience etc. for vacant post / posts and ensure that they hold the required mandatory qualification (educational) and others for the post and only those who are covered under the prescribed age limit can apply online.
7. It is mandatory for the candidate to tick the requested post while registering; otherwise his/her application will not be accepted.
8. The number of vacancies may increase or decrease.
9. Age relaxation for SC/ST& OBC candidates up to a maximum period of 05 years, as per relevant GOs of Govt of UP.
10. In case of Permanent Government Employees of UP Govt, who have rendered not less than 3 years regular and continuous service in the relevant field relax able up to maximum period of 5 years as per relevant GOs of Government of UP.
11. Relaxation to upper age limit in favor of Ex-serviceman will be as per Government of UP which eventually followed Govt. of India rules.
12. No document including printed/ hard copy of online application forms are required to be sent by post. However, applicants are advised to keep one printed / hard copy of their application forms.
13. Applicants in regular employment must submit a "NO OBJECTION CERTIFICATE" from employers.
14. Candidates with valid application number and eligible for the post applied shall only be called for Interview.
15. No TA/DA shall be admissible for appearing in Interview.
16. All Disputes/differences or litigations shall be subject to territorial jurisdiction of Lucknow Court only.
17. Director SGPGIMS, Lucknow reserves the right to fill any or all of advertised posts or not to fill the same without assigning any reason. The provisions provided in SGPGIMS Act 1983, SGPGIMS Regulations, 2011 and amendments made therein from time to time shall prevail in case of any controversy or inconsistency in this advertisement.

Age -Limit

1. The decisive date of age calculation for recruitment to all the posts of the Institute is 1st January, (in case if Advt is released in between 1st January to 30th June) and 1st July (in case if Advt is released in between 1st July to 31st December) of that year. As such in the instant advertisement the decisive date is 1st July, 2024, the candidate has attained the age of 18 years and has not attained the age of more than 50 years / 55 years in case of Deputation (Ref.- UP Absorption of Government Servants in Public Undertakings Rule, 1984) as on 1st July, 2024.
2. In case of candidates belonging to Scheduled Castes, Scheduled Tribes, OBCs and other such categories of candidates in Uttar Pradesh, the upper age limit will be as high as specified by the Government.

3. In case of Permanent Government Employees of Government of UP who have rendered not less than 3 years regular and continuous service in the relevant field, the age is relaxable up to maximum period of 5 years as per GOs of Govt of UP, Karmik Anubhag -4 Ref No. -2-E.M./2001-Ka-42013 dated 27.08.2013.
4. For appointment on direct entry posts an ex-service man vide U.P.Govt Niyukti (kha) depts no. 5/1/66-niyukti (kha) dated 16.3.1970, he shall be allowed to deduct the period of his service in the armed forces from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post / service for which he seek appointment by more than 03 years, he shall be deemed to satisfy the condition regarding the upper age limit. However, he should have rendered satisfactory approved military service in any wing of army, navy or air forces and he should be otherwise eligible for the post.
