<u>Instructions to Selected Candidates (for Appointment or Clarification)</u>

- **3.** The selection is against the number of vacancies as per the information provided from CMS Office, SGPGIMS.
- **4.** The intimation regarding the same and joining, etc, has been emailed to all selected candidates at their registered email IDs
- **5.** The Candidate is requested to bring a print out of the email and original govt. issued photo ID/Aadhaar card.
- **6.** As per the Selection Committee recommendations (approved by the competent authority), Appointment letters will be issued to those candidates who have been found eligible and Clarification letters would be issued to those candidates who are required to submit further documents, as per the terms of the advertisement.
- 7. You are hereby informed that original copy of Appointment/ Clarification letter should be received from the Recruitment Cell (Room No. 228, 1st Floor Adm Block, SGPGIMS) (timing 10AM to 4PM on working days) on 17.01.2024 or within 30 days thereafter.
- 8. You are further informed that you will be required to report to the CMS Office, SGPGIMS, for joining after receiving the Appointment Letter, within one month of date of dispatch of the appointment letter, failing which your appointment is liable to be cancelled, as per the decision of the Director SGPGIMS. Kindly follow the process of joining as instructed by the CMS office.
- **9.** The original appointment letters <u>WILL **NOT** BE MAILED TO THE CANDIDATES'</u> physical ADDRESS.
- **10.** The Candidates who have been issued Clarification letters are requested to kindly provide the required documentation to the Recruitment section within the specified time-period so that the Selection Committee can take a decision on their eligibility for appointment, failing which ytheir candidature is liable to be cancelled.
